Mr. Kennedy,

I am writing to outline the Campaign to Stop Stericycle (CSS), a nationally-concerted effort that is exposing Stericycle, the leading medical waste company in the nation, for its collection, transportation and incineration of aborted children and the tools used to kill them. I am also writing to implore you not sign any contracts with Stericycle that involve servicing the abortion industry, and that if Stericycle is already using Westran Idealease trucks for this purpose that you stop allowing them to do so.

Recently, Ryder System Inc. prohibited Stericycle from using its trucks nationwide to service abortion facilities. As a result, Stericycle will likely now be approaching Idealease affiliates to seek lease agreements in place of Ryder. It is important that you understand that if you sign a contract with this medical waste company – whether individually or through a contract presented from the Idealease corporate headquarters – you will be facilitating the means for Stericycle to haul aborted children for incineration. I sincerely hope that you do not desire to be involved in such a business relationship.

Regardless of where you stand on the issue of abortion, it is a fact that Stericycle collects containers that have been filled with the discarded hands, feet and once beating hearts of children and incinerates them with the trash. In fact, Stericycle was recently investigated in the state of Texas for illegally dumping aborted fetuses into a municipal landfill, and admitted to the government that the fetuses are normally transported to an incineration plant for disposal. Additionally, it has been documented in Pennsylvania by the Philadelphia District Attorney's Office that Stericycle had serviced notorious abortionist Kermit Gosnell, who is now facing murder charges. 

We do not want the public to be opposed to your business, but if you partner with Stericycle in this manner, you will be subjected to national resistance from those who value life and the precious gift of children.
